

TAX LEVY ORDINANCE
BURTON TOWNSHIP ROAD DISTRICT
ORDINANCE No. 2021-22

An ordinance levying taxes for all road purposes for **Burton Township Road District**,
McHenry County, Illinois, For the tax year 2021, which is collectable in 2022

BE IT ORDAINED by the Board of Trustees of **Burton Township**,
McHenry County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Burton Township Road District on
December 14, 2021 does hereby determine and declare that the sum of *two hundred
forty-five thousand twenty-four dollars* and No cents (*\$245,024*) are hereby levied upon
all property subject to taxation within the Road District as that property is assessed and
equalized.

In order to meet and defray all the necessary expenses and liabilities of the Road District
as required by statute or voted by the people in accordance with the law for the
purposes as:

1. Road and Bridge
2. Permanent Road
3. Equipment and Building
4. Road Damage

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for **Burton Township Road District**.


