

**TAX LEVY ORDINANCE**  
**BURTON TOWNSHIP ROAD DISTRICT**  
**ORDINANCE No. 2022-23**

An ordinance levying taxes for all road purposes for **Burton Township** Road District, **McHenry** County, Illinois, For the tax year 2022, which is collectable in 2023

BE IT ORDAINED by the Board of Trustees of **Burton Township**, McHenry County, Illinois, as follows:

**SECTION 1:** That the Highway Commissioner of Burton Township Road District on December 13, 2022 does hereby determine and declare that the sum of **Two Hundred Fifty-Six Thousand Seven Hundred Eighty-Four Dollars** and No cents (**\$256,784**) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized.

In order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law for the purposes as:

1. Road and Bridge
2. Permanent Road
3. Equipment and Building
4. Road Damage

**SECTION 2:** That the amount levied for each object and purpose shall be as follows:

**SECTION 3:** That the Town Clerk shall make and file with the County Clerk of said County of **McHenry**, on or before the last Tuesday in December, a duly certified copy of this ordinance.

**SECTION 4:** That if any section, subdivision, or sentence of this ordinance shall for any reason beheld invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

**SECTION 5:** That this ordinance shall be in full force and effect after its adoption, as provided by law.


