TAX LEVY ORDINANCE
BURTON TOWNSHIP
ORDINANCE No. 122022-23

An ordinance levying taxes for all town purposes for **Burton Township**, McHenry County, Illinois. For the tax year 2022, which is collectable in 2023

Be it ordained by the Board of Trustees of **Burton Township**, McHenry County, Illinois, as follows:

Section 1:

That the sum One Hundred Seventy-Three Thousand Two Hundred Thirty Dollars and No Cents (**\$173,230.00**) are hereby levied upon all property that is assessed and equalized, in order to meet and defray all necessary expenses and liabilities of the Township as required by the people in accordance with the law, for such purposes as:

1. General Town Fund
2. Public Assistance Fund

Section 2:

That the Town Clerk shall make and file with the County Clerk of the said County of McHenry, on or before the last Tuesday of December, a duly certified copy of this ordinance.





Section 3:

That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such findings shall not affect the validity of the remaining portion of this ordinance.

Section 4:

That this ordinance shall be in full force and effect after its adoption, as provided by I

ADOPTED this 13th day of December, 2022 pursuant to a roll call vote by the Board of Trustees of **Burton Township, McHenry County, Illinois.**





I, the undersigned, hereby certify that I am the presiding officer of BURTON TOWNSHIP and as such presiding officer I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Section 18-60 through 18-85 of the "Truth in Taxation" law.

- The taxing district published a notice in the newspaper and conducted a hearing meeting the requirements of the Truth in Taxation Law.
- The taxing district's aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a notice and a hearing were not necessary.
- The proposed aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a hearing was not held. The adopted aggregate tax levy exceeded 5% of the prior year's extension and a notice was published within 15 days of its adoption in accordance with the Truth in Taxation Law.
- The adopted levy exceeded the amount stated in the published notice. A second notice was published within 15 days of the adoption in accordance with the Truth in Taxation Law.
