Burton Township ROAD DISTRICT Tax Levy Ordinance No. 122024-25

An ordinance levying taxes for all town purposes for Burton Township Road District, McHenry County, Illinois, for the tax year 2024 , collectable in 2025

BE IT ORDAINED by the Board of Trustees of Burton Township, McHenry County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Burton Township Road District on *December 10, 2024*, does hereby determine and declare that the sum of **Two Hundred Nineteen Thousand Seven Hundred Thirty-One Dollars (\$219,731)** is hereby levied upon all property within the Road District so that property is assessed and equalized.

In order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

1. Road and Bridge
2. Permanent Road
3. Equipment and Building
4. Road Damage

for the year 2024.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

Road Damage Tax	\$17,543
Revenue Recapture	\$ 558

SECTION 3: That the Town Clerk shall make and file with the County Clerk of said County of McHenry, on or before the last Tuesday of December, a duly certified copy of this ordinance.

SECTION 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.

**TRUTH IN TAXATION
CERTIFICATE OF COMPLIANCE**

I, the undersigned, hereby certify that I am the presiding officer of Burdor
Township - Road, (Legal Name of Taxing District), and as such presiding
