Tax Levy Ordinance No. 122023-24

An ordinance levying taxes for all town purposes for Burton Township, McHenry County, Illinois, for the tax year 2023 , collectable in 2024 .

BE IT ORDAINED by the Board of Trustees of Burton Township, McHenry County, Illinois, as follows:

SECTION 1: That the sum of *One Hundred and Seventy-One Thousand and Three Hundred and Sixty-Five Dollars (\$171,365)* are hereby levied upon all property that is assessed and equalized, in order to meet and defray all necessary expenses and liabilities of the Township as required by the people in accordance with the law, for the purposes as;

In order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

1. General Town Fund
2. Public Assistance Fund

SECTION 2 That the Town Clerk shall make and file with the County Clerk of said County of McHenry, on or before the last Tuesday of December, a duly certified copy of this ordinance.

SECTION 3: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 4: That this ordinance shall be in full force and effect after its adoption, as provided by law.

BURTON TOWNSHIP LEVY


